- These securities will convert on a 1-for-1 basis into shares of the issuer's common stock.
- These service-based securities vest in four equal installments on the first, second, third and fourth anniversaries of the date of grant. The first tranche will vest on August 17, 2018, the second on August 17, 2019, the third on August 17, 2020 and the fourth on August 17, 2021.
